**Call for Application**

**BACKGROUND**

In June 2013, with the matching from the Sixth Government Matching Grant Scheme and The University of Hong Kong's (HKU) 'Turn 1 to 5' Campaign, the Faculty of Education received donations and/or a matching grant for the establishment of scholarships.

**APPLICATION REQUIREMENTS**

Full-time UGC-funded Postgraduate Diploma in Education (PGDE) students who are permanent residents of Hong Kong and have participated/will participate in experiential learning (EL) activities<sup>1</sup> organised or approved by the Faculty of Education in 2025-26 are eligible to apply. Successful students should demonstrate good academic standing, as well as having a strong interest in and commitment to EL.

**POINTS TO NOTE**

**1. Application Procedures**

Interested students should submit the following documents to the EL Team by email: [eledu@hku.hk](mailto:eledu@hku.hk)

- (a) the completed Application Form (Annex) with proof of academic record;
- (b) a copy of your HKID card;
- (c) a one-page curriculum vitae of major highlights of personal profile and strengths;
- (d) a one-page statement of how you have benefited/will benefit from the EL activity; and
- (e) a one-page information sheet about the details of the activity and an estimated budget/actual expense summary of the activity fees and related expenses (please indicate if you have other funding sources).

**2. Application Deadline**

Application must be submitted on or before **March 31, 2026 (Tuesday)**. Late or incomplete applications will NOT be accepted.

**3. Application Result**

Application results will be announced via email by June 2026. Successful students will be required to submit a sharing report on their EL programme and participate in public sharing sessions. They may also be invited to take part in production of videos and/or other activities which might help to promote the study programmes in the Faculty. The Faculty of Education reserves the right to publish or reprint the report and relevant photos/videos, either online or in print.

**4. Selection Criteria**

- ✓ Good academic standing
- ✓ Strong interest in and commitment to EL
- ✓ Demonstration of specified experience and learning outcomes they have achieved after their participation in the Faculty's EL programmes

## **5. Amount**

The amount of the Scholarship shall be determined by the Selection Committee according to students' programme fees and related expenses of the EL activity. Each awardee may receive a maximum of HK\$5,000. The Scholarship cannot be concurrently held with other merit-based enrichment scholarships administered by the University for the same activity. It may be held concurrently with non-merit-based financial aid. If a student receives multiple grants or financial aid for the same EL activity, the Faculty of Education reserves the right to adjust the total amount awarded or reimbursed to ensure it does not exceed the actual expenses incurred.
