Call for Application

BACKGROUND

In 2012, Professor Lam Chi Chung generously pledged a donation to the Faculty of Education, The University of Hong Kong (HKU) for the establishment of a scholarship in memory of his mother-in-law, Madam Chu Kwai Ying. The Scholarship has been awarded to students participating in the **Faculty's experiential learning (EL) programmes** since the academic year 2012-2013.

APPLICATION REQUIREMENTS

Students of the following programmes who have a Cumulative Grade Points Average (CGPA) of not less than 3.00 and have participated/will participate in EL activities¹ organised or approved by the Faculty of Education in 2025-26 are eligible to apply:

- Bachelor of Arts and Bachelor of Education in Language Education (Chinese or English)
- Bachelor of Education and Bachelor of Science
- Bachelor of Education and Bachelor of Social Sciences

POINTS TO NOTE

1. Application Procedures

Interested students should submit the following to the EL Team by email: eledu@hku.hk

- (a) the completed application form (Annex);
- (b) a one-page curriculum vitae of major highlights of personal profile and strengths;
- (c) a one-page statement of how you have benefited/will benefit from the EL activity; and
- (d) a one-page information sheet about the details of the activity and an estimated budget/actual expense summary of the activity fees and related expenses (please indicate if you have other funding sources).

2. Application Deadline

Application must be submitted on or before **March 31, 2026 (Tuesday)**. Late or incomplete applications will NOT be accepted.

3. Application Result

Application results will be announced via email by June 2026. Successful students will be required to submit an activity report of the EL project in the form of a thank-you letter. They may also be invited to take part in production of videos and/or other activities which might help to promote the study programmes in the Faculty. The Faculty of Education reserves the right to publish or reprint the report and relevant photos/videos, either online or in print.

4. Selection Criteria

- ✓ Good academic standing
- ✓ Strong interest in and commitment to EL

¹ Chinese and English Immersion Programmes are not included since these programmes are partially funded by the Government.

5. Amount

The amount of the Scholarship shall be determined by the Selection Committee according to students' programme fees and related expenses of the EL activity. Each awardee may receive a maximum of HK\$10,000. The Scholarship cannot be concurrently held with other merit-based enrichment scholarships administered by the University for the same activity. It may be held concurrently with non-merit-based financial aid. If a student receives multiple grants or financial aid for the same EL activity, the Faculty of Education reserves the right to adjust the total amount awarded or reimbursed to ensure it does not exceed the actual expenses incurred.
